#### **Experience:**

With Bill's commercial real estate brokerage career having begun in 2000, he has consistently been the top annual producer in commercial transactions among his peers in Yakima County, both in sales and leasing volume and in number of closed transactions, and has established himself as the market expert in all aspects of office, retail and industrial sales and leasing. He has closed approximately 800 commercial transactions in excess of \$350,000,000 and consistently markets between 20 - 40 properties for sale or lease at any given time. He has closed more commercial transactions than any active or retired broker within Yakima County.

Bill benefits from an established reputation and has strong local relationships that have allowed him to use his skillsets to successfully navigate the Yakima County commercial real estate market. Despite opportunities to take on projects in other market areas, he has consistently maintained a willingness to work only in Yakima County and spends the vast majority of his efforts and time solely within the city of Yakima and its general surrounding submarkets. By focusing only on the greater Yakima market areas, he feels he's able to maintain a necessary level of expertise and offer the most value to his clients and projects.

Bill achieved the CCIM designation shortly after his first year in business, which is regarded as the highest achievable investment grade designation within the commercial real estate industry.

As a supplement to Bill's brokerage work, he has successfully acquired, managed and repurposed more than 350,000SF of private placement commercial investment properties, many of which have been 'value-add' projects, and all of which have been owned with clients as passive partners (he does not acquire properties without clients). As managing member of those properties, he has spearheaded all aspects of these investment holdings, from acquisition, underwriting, design, construction, project management, leasing and selling, and has successfully negotiated both favorable insurance settlements and obtained favorable lease audit results. To date, the lowest true internal rate of return he has achieved within these projects has been approximately 20%, and all have exceeded their original projections.
